This waiver and release does not apply to any items, modifications, or changes pending approval; disputed items and claims; or items furnished or invoiced after the Payment Period.

The undersigned warrants that the aforementioned conditions have been met and that undersigned has (1) received and properly endorsed a check in the Payment Amount payable to the undersigned, (2) the check has been paid by the depository institution on which it was drawn; and (3) the undersigned either has already paid or will use the money the undersigned has received from this progress payment promptly to pay in full all the undersigned's laborers, subcontractors, materialmen, and suppliers for all work, materials, equipment, or combination of work, materials, and equipment that are the subject of this waiver and release. The undersigned acknowledges that Stacey Enterprises, Inc. is relying on its representation that it has received the Payment Amount.
